Motion made and seconded to approve the minutes of the June 8, 2016 meeting. **All in favor.**

COLA:

Chief Gilliland requested this meeting to re-address the June 9th COLA discussion and vote. Chief Gilliland gave the voted 2.5% increase (on the first \$12K of retirement earnings) considerable thought and realized as voted the COLA was only an average of a 1% increase on an average pension. In hind sight Chief Gilliland felt this was unjust and unfair compared to the increase budgeted to active town employees of 2 ½%.

Discussion ensued with the Board split on approving an additional 0.5%. Arguments supporting both positions were introduced and debated. Chief Gilliland made a motion to increase the COLA to the full 3%, the motion was seconded and voted. **Nieto, Gilliland and Jalbert in favor, Peck and Gessner opposed.**

Motion made and seconded to adjourn at 8:26 AM. **All in favor.**
