The Board further concluded that Monahan's permanent incapacity is the natural and proximate result of the personal injury sustained on December 8, 2014. Motion made and seconded to grant the Application of Frank T. Monahan, Jr. and retire him for accidental disability provided, however, that said grant of accidental disability is subject to review by the Public Employee Retirement Administration Commission pursuant to the provisions of M.G.L. c. 32, § 21(1)(d). **All in favor.**
