Regular Business: Meeting called to order at 4:06 PM at Mary Alley Municipal Building, 7 Widger Road, Marblehead, MA 01945 – Lower level Conference Room

Minutes:

Motion made and seconded to approve the minutes of the June 16, 2022 meeting. **All in favor.**

Funding Schedule:

John Boorack, PERAC Actuary, presented a detailed explanation on plan liabilities, plan assets and revised actuarial assumptions from the previous valuation. PERAC has recommended decreasing the investment return assumption from 7.15% to 7.0%. In addition, Mr. Boorack included 2 funding schedules as follows: Alternative 1 amortizes the unfunded liability on an 8.6% increasing basis until FY35 with a final amortization payment in FY36 which is 3 years earlier than the prior 01/01/2020 valuation. As a result of the favorable financial change from the prior

analysis, Alternative 2 amortizes the unfunded liability on a 7.35% increasing basis until FY37 with a final amortization payment in FY38. PERAC was encouraged by the gains of the system and recommended remaining with the 8.6% increasing basis. Moved and seconded to reduce the investment return assumption to 7.0% and adopt Alternative 1 with an 8.6% total increase in appropriation each year. **All in favor.**

Fifth Member Election:

The Board conducted interviews for the Fifth Board Member position with the incumbent, Mr. Robert Peck, Jr. as well as two external applicants, Mr. Harlan Strader and Ms. Denise Timmons. Motion made and seconded to nominate all applicants with a term to expire in July 2025. On a polled vote the Board voted as follows: Mr. Jalbert, Robert Peck; Chief Gilliland, Robert Peck; Mr. Carritte, Robert Peck; Mr. Gessner, Robert Peck. Robert F. Peck, Jr. elected as the Fifth Member of the Marblehead Retirement Board with a term to expire in July 2025.

Motion made and seconded to adjourn at 4:35 p.m. **All in favor.**
