

**MARBLEHEAD BOARD OF HEALTH  
EMERGENCY MEETING  
MINUTES, December 29, 2021**

Web-based video conferencing meeting of the Board of Health via Zoom.

Meeting called to order at 7:30pm.

Chairman Belfbecker opened the meeting noting the disrespect and lack of decorum by the public at the meeting on December 27<sup>th</sup>. He explained that “open meetings” (see <https://www.mass.gov/service-details/updated-guidance-on-holding-meetings-pursuant-to-the-act-extending-certain-covid-19-measures>) can be conducted in multiple ways and the public may or may not be allowed to speak. He then went on to explain how the public comment would be allowed at the meeting this evening with a total time allotment of 30 minutes; those wishing to speak are to use the “raised hand” icon; each person is to state their name, address, and will be allowed 2 minutes to speak; questions will not be answered. After this time the Board will vote on reaffirming the masking mandate.
