The Chair called the meeting of April 9, 2025 to order.

PUBLIC COMMENT. None.

TOWN ADMINISTRATOR UPDATE. The Town Administrator updated the Board on the following:

- June Elections Due to current issues with the Lift at the Old Town House and the Elevator at Abbot Hall, neither location will be Handicapped Accessible for the elections in June. Working with other town departments we are looking to relocate voting in June to the Field House at Marblehead High School. The current lift at the Old Town House cannot support repetitive use in short time spans due to a coolant issue and it shuts down trapping people inside. There is a State mandatory safety upgrade required for the elevator at Abbot Hall. This project has been procured and a contract awarded. Abbot Hall elevator will be shut down for 6-8 weeks to complete the work. Any change in location needs to be certified by the State before the Select Board can vote to relocate voting in June and the Town Clerk is required to give 20 days' notice registered voters. The Town Administrator will advise the Board as more information becomes available.
- Free Cash Certification update—all expenditures have been fully reconciled and documented on the expenditure side. Final reconciliation of the revenue accounts relative to the bank accounts is complete and we are working on the accounting side to complete this process.
- The Town's annual Employee Benefits Fair, organized by Amanda Viecelli, Benefits Coordinator, was held earlier today at Mary Alley and was very successful.

ABBOT PUBLIC LIBRARY. National Library signs. Kim Grad, Director, Abbot Public Library, appeared before the Board seeking approval to install 2 National Library Signs on the public ways. The Board had an extended discussion on the purpose and placement of the signs with the Chair noting that there has been an effort over the years to clean up the excess number of signs in Town. After discussion a motion was made and seconded to approve the request, as amended, from Kimberly Grad, Director, Abbot Public Library, and amend the request to erect one National Library Sign subject to review and approval by the Town Administrator and DPW Director.
