Bids for the Project will be accepted electronically (E-Bid), by Projectdog at www.projectdog.com until December 5, 2024, at 1:00 PM. All questions are due by 4:00 PM, November 26, 2024. There will be a non-mandatory, on-site briefing session scheduled for November 21, 2024, at 10:00 AM.

Bidders may obtain one (1) full paper bid set for a refundable deposit of \$150 in the form of a certified check or money order payable to Projectdog, Inc.
