Evaluation Criteria for Master Plan Advisory Group Applicants

The evaluation process will consider the following key areas:

1. Relevant Experience and Expertise

Applicants will be assessed on professional, academic, and volunteer experience relevant to: Health and Safety, Sustainability, Land Use + Zoning, Historical Preservation, Economic Stability and Development, Infrastructure, Housing, Education, and Transportation/Mobility

2. Commitment to Community Engagement

Strong applicants will demonstrate a commitment to meaningful community engagement, transparency, and consensus-building. Experience working with the public, leading outreach efforts, or participating in civic and neighborhood initiatives will be considered valuable.

3. Analytical and Critical Thinking Skills

Applicants should show the ability to review and interpret complex data, analyze planning and policy issues, and make informed, balanced decisions. Evidence of strategic thinking, problem-solving, or decision-making in previous roles will strengthen an application.

4. Availability and Commitment

Advisory group members will be expected to commit the necessary time and energy to participate actively in meetings, review planning documents, attend public forums, and collaborate with staff and consultants. Applicants should clearly outline their availability and readiness to serve throughout the entire Master Plan process, which may extend over many months.

5. Communication and Collaboration Skills

The ability to work effectively in a group setting is critical. Applicants should demonstrate respectful communication, active listening, and a constructive approach to discussion and decision-making. Experience on committees, boards, or collaborative teams is beneficial.

6. Vision and Motivation

Applicants should express a strong personal motivation for participating in the Master Plan process and articulate a thoughtful vision for the future of the community. A demonstrated passion for civic life and a desire to contribute to long-term planning goals will be important considerations.

All applicants will be evaluated holistically, with an emphasis on the overall contribution they can make to the advisory group. We encourage individuals with a range of backgrounds and perspectives to apply.

The selection of two applicants will be completed by August 12th by the Planning Board
