1. 25 Mechanic St.

David & Concetta Donovan

This is an application for: Replacement of existing shingles with new cedar shingles on rear and side.

It was moved, seconded, and voted (6-0) that no estates are materially affected and to grant a Certificate of Appropriateness for: All work as proposed. New shingles to weather to match existing.

2. 104 Front St.

Pamela Cassidy

This is an application for: Replace existing 6 ft. high wood stockade fence with new wood fence to match and gate, Add new metal railing to front steps.

It was moved, seconded, and voted (6-0) that no estates are materially affected and to grant a Certificate of Appropriateness for: All work as proposed.

This is an application for: New curb cut to access existing parking space.
