**MINUTES.** Motion made and seconded to approve the minutes of January 11, 2005.  
All in favor.

**MARBLEHEAD PUBLIC SCHOOLS. Superintendent of Schools Search.**

Patricia Blackmer and Amy Drinker, School Committee liaisons for the Superintendent search. Copies of the New England School Development Council (NESDEC). Focus Group Report were presented to the Selectmen for their review. (NESDEC has been retained by the School Committee to assist the town in its search for a new Superintendent of Schools.)

**MARBLEHEAD HISTORICAL COMMISSION. Web Update.** Wayne T. Butler, Commission member, and Chris Johnston, Commission volunteer were present to advise of some of the materials to be included on the Marblehead Historical Commission Archives web-site page, currently under development.

**MARBLEHEAD FOREVER. Award.** Wayne T Butler awarded the “Keep the Marblehead Spirit Alive” award for 2005.

**TRAFFIC AND SAFETY COMMITTEE. Recommendations.** Motion made and seconded to accept the following recommendations approved by the Committee members on January 12:

Request that Keyspan Gas move a solar panel blocking a sign on the north side of Evans Road near Elm Street;

Install a “No Parking to Corner” sign at the pet store located at the corner of Evans Road and Elm Street;

Cross hatch the south side of Evans Road from Elm Street to beyond the first driveway;  
and

Cross hatch and install a “No Parking to Corner” sign on the north side of Elm Street at Evans Road.

**RECREATION, PARKS & FORESTRY DEPARTMENT. Revolving Fund.**

Request from R. Thomas Hamond, Superintendent requesting the continuation of the existing revolving fund in the amount of \$ 300,000 for fiscal year 2007. Motion made and seconded to reauthorize the fund. All in favor.

**PERMISSION. Bike Race.** Request from Christopher M. Finn, of Marblehead Cycle Inc. to hold a bike race on Sunday, April 2 and to place two portable restrooms at Devereux Beach. Motion made and seconded to approve the race on April 2 from 8:00 a.m. to 1:00 p.m. subject to police and fire approvals and that no permanent markings be made on the streets of our town. All in favor.

Request from Christopher M. Finn, of Marblehead Cycle Inc. to hold al bike race on Sunday, April 2 from 8:00 a.m. to about noon and to place two portable restrooms at Devereux Beach. Motion made and seconded to approve subject to police and fire approvals and that no permanent markings be made on the streets of our town. All in favor.

**PERMISSION. Walk.** Request from Erin Mondello, Executive Director of BANE Skilled Care Residences requesting permission to host a walk called the “Devereux House Mosaic Memory Walk Around the Neck” on either June 3, 10 or 17. The purpose of the event is to build public awareness about the disease, raise funds and honor individuals. Proceeds to benefit the Alzheimer’s Association and BANE’s Social Enrichment Program for residents, in equal parts. Motion made and seconded to approve the walk to be held on June 3, subject to police and fire approvals and that no permanent markings be made on the streets of our town. All in favor. Town Administrator Anthony M. Sasso was asked to ascertain from Ms. Mondello the hours during which the event is to be held.

**BOARD OF HEALTH. Revolving Fund.**

Request from Wayne O. Attridge, Director of Public Health requesting to continue a revolving fund dedicated to commercial waste disposal for FY 07 not to exceed the amount of \$450,000 for fiscal year 2007. Motion made and seconded to authorize the fund. All in favor.
