CHAIRMAN PRO TEMP. Motion made and seconded to appoint Judith R. Jacobi Chairman Pro Temp for the meeting. All in favor.

EXECUTIVE SESSION. Motion made and seconded to adjourn to Executive Session under M.G.L. c. 30A, Sec. 21 for the purpose of discussing pending litigation where the public discussion on the same may have a detrimental effect on the negotiating position of the public body, votes may be taken, and if they are votes will be released at a time deemed appropriate by counsel. MINUTES. Motion made and seconded to approve the minutes from November 18, 2015. All in favor.

GAS LEAKS LEGISLATION. REPRESENTATIVE LORI A. EHRLICH. Representative Lori A. Ehrlich appeared before the Board to talk about two bills before the House relative to gas leak legislation; House Bill 2870 precludes utility companies from charging customers for cost of lost and accounted for gas, protecting consumers from expenses that they have no ability to control or reduce and House Bill 2871 requires all gas leaks under a road to be repaired when the road is opened up for a construction project. This was presented as a sensible, cost-saving, efficient way to ensure that more leaks are repaired. Representative Ehrlich noted that Marblehead currently has 173 unrepaired gas leaks. Motion made and seconded to support both bills. All in favor.

FIRE DEPARTMENT. Equipment. Chief Jason Gilliland appeared before the Board seeking the Boards support to place an article on the warrant for the 2016 Annual Town Meeting to purchase a new pumper for the Fire Department. The pumper was originally scheduled to be replaced in 2013. The approximate replacement cost is \$650,000.

TOWER SCHOOL. Proposal for Street Abandonment. Colgate Road. Dean Sidell, Business Manager, Tower School, Robert McCann, Counsel, Dr. Andrew Taylor, Head of School and Matthew Kealey, VBM Engineering, appeared before the Board seeking support for the Tower Schools proposal to request the town to abandon and discontinue a portion of Colgate Road. The Tower School project proposes the construction of a circulation loop that will provide an off street drop off and pick up area and additional parking spaces. The loop will be the primary drop off and pick up point greatly reducing the queues on West Shore Drive thus improving congestion and delays at the intersection of West Shore Drive and Cornell Road. The Tower School has met with the Planning Board and has implemented the changes, as suggested by the Planning Board, into their
