**MINUTES.** Motion made and seconded to approve the minutes of August 20, 2021 and August 25, 2021. Moved by Mr. Nye, seconded by Mr. Grader. **DRAIN EASEMENT. 9 Treat Road.** Attorney Robert McCann appeared before the Board representing Joshua Henry Kline and Skylar Ariel Frisch, owners of 9 Treat Road, seeking a relocation of easement on their property. Town Counsel, Zoning Board of Appeals and DPW have all approved this relocation. Motion made and seconded to approve the Relocation of Easement, 9 Treat Road, as presented, and authorize the Chair to sign on behalf of the Board. Moved by Mr. Nye, seconded by Mr. Grader. **POLICE DEPARTMENT. **PARKING RESTRICTIONS. Round House Road. Annual Clean up.** Motion made and seconded to approve the request from Rob Dever, Public Works Director, to

temporarily make the entirety of the Railroad Right of Way known as Roundhouse Road, from School Street through to Bessom Street, as well as upper Anderson Street from #10 Anderson through to Bessom Street a **NO PARKING/TOW ZONE** area for the following dates:

October 19, 2021 from the hours of 7:00 a.m. – 3:00 p.m.

Rain Date: October 20, 2021 from the hours of 7:00 a.m. - 3:00 p.m.

**CONTRACT. **CONTRACT. Fort Sewall Renovation. Amend.** Motion made and seconded to amend the contract between the Town and Sciaba Construction, for the Fort Sewall renovation project, by increasing the amount by fifty-nine thousand one hundred forty-nine and 90/100 (\$59,149.90) and authorize the Chair to sign on behalf of the Board. Central Street.** Motion made and seconded to approve the request from Katie and Farouk Al-Shorofa to allow parking in front of 9 Central Street on Saturday, November 13, 2021 from 5:00 p.m. – 7:30 p.m. for a video game truck to park for a children’s birthday party subject to approval from Police and Fire.
